Once you have completed your Application Packet and obtained the necessary signatures, bring your signed application forms, your Driver's License and a copy of your DRE License to the DAR office.

Joining the Delta Association of REALTORS® will take approximately 30 minutes of your time with Association Staff.

Please note that if payment is by check you will need to have TWO separate checks, one made to EBRD for MLS services and the other made to DAR for Board membership and Key.

Following the completion of the application process, you must register for and attend a MANDATORY orientation. Completion of a 3 hour course on the National Association of REALTORS® Code of Ethics and attendance at the Delta Association New Member Orientation are membership requirements which must be fulfilled within 45 days of applying for membership.
