Dear Applicant:

Once you have completed your Application Packet and obtained the necessary signatures, bring your signed application forms, your Driver's License and a copy of your DRE License to the DAR office.

Joining the Delta Association of REALTORS® will take approximately 30 minutes of your time with Association Staff.

Please note that if payment is by check you will need to have TWO separate checks, one made to EBRD for MLS services and the other made to DAR for Board Membership and Supra Key.

Following the completion of the application process, you must register for, and attend a MANDATORY orientation. Completion of a 3 hour course on the National Association of REALTORS® Code of Ethics and attendance at the Delta Association New Member Orientation is a membership requirement which must be fulfilled within 45 days of applying for membership.

DAR Staff will assist you in scheduling your orientation date and how to complete your ethics course online.

Dues and Fees

Association Dues/Fees are prorated on a monthly basis with the exception of the NAR Image Fee, and may contain one-time fees such as the DAR Application Fee (\$175.00) and State Application Fee (\$30.00).

The yearly Local, State and National Association Dues are as follows:

Semi-Annual Local Association Dues:	\$440.00	\$220.00 Due in January \$220.00 Due in July
Annual State (CAR) Dues:	\$184.00	\$184.00 Due in January
Annual National (NAR) Dues:	\$120.00	\$120.00 Due in January
Annual National (NAR) Image Dues:	\$ 35.00	\$ 35.00 Due in January

If applicable, your EBRD MLS Fees (\$495) and Supra KEY (\$113.59 + \$9.37 tax =\$122.96) Fees are due in October. Subscribing to either of these services requires a separate application and application fee.

Dues and Fees are subject to change at any time without notice.

The billing from DAR will come via e-mail. No paper billing will occur.

VARIABLE DUES FORMULA: The dues for each Designated REALTOR® are increased by \$744 for each employed licensee who chooses not to be a member of an Association of REALTORS®. This fee is a non-member assessment and is part of the broker's dues, NOT the agent's. Paying this fee will not qualify agents as members of DAR.
